WHAT INFORMATION DO WE COLLECT?

We collect information from you when you fill out a form, place an order, respond to communication such as an email or participate in another site feature such as registration or non-registered downloads or purchases.

You can visit our site anonymously, however when you place an order, or obtain a free download we do require your first and last name and email address (and possibly credit card information through partner payment solutions) to fulfill the order. If you are purchasing products that must be shipped we will require your physical shipping address.

HOW DO WE USE YOUR INFORMATION?

We may use any of the information we collect form you when you purchase products, when you register, when you subscribe, or respond to communication such as an email, when you surf the website or use certain other site features in the following ways:

- To allow us to quickly and efficiently process your transactions
